The concerns identified a lack of appropriate infrastructure and public services to cope with the increased dwellings identified within the Forest of Dean District Council's Local Plan, 2021-2043.

The Regeneration Working Party recommended the following:

 The Regeneration Committee and Working Party continue to work with Place Studios, who are currently preparing a summary of all data collected during the consultation, along with their recommended changes. Once this summary is reviewed and agreed upon, the Regeneration Committee/Lydney Town Council (LTC) will be able to release a public statement.

Timeline for Submission

- Changes anticipated to be completed by September/October 2025.
- By October 2025, all revised documents will be ready for public display.
- Lydney Town Council to endorse the final version of the plan at the Full Council Meeting on 10th November 2025.
- Plan to be submitted to FoDDC by November 2025.

Post-Submission Timeline

- Regulation 16 consultation will occur 1–2 months post-submission and will remain open for 6 weeks.
- All comments received will be forwarded to the examiner.
- FoDDC will arrange the examination.
- Examination window: Spring–Summer 2026
- Referendum: Expected to take place in Autumn 2026

- 5. FOREST OF DEAN DISTRICT COUNCIL LOCAL PLAN 2021-2043, CONSULTATION LOCAL PLAN OPTIONS TO DELIVER THE ADDITIONAL HOUSING REQUIREMENT
- 5.1 To review, consider and decide on the submission to the response to the consultation from the Forest of Dean District Council by 30th September 2025.

Following consideration of the Local Plan options, the committee identified a range of housing constraints within the Forest of Dean. It was acknowledged that all potential options are likely to result in adverse impacts on Lydney.

Accordingly, future housing allocations should be directed to locations that demonstrate the least environmental impact, including factors such as traffic, air quality, and sustainable transport connectivity (for example, bus services linking the railway station and bus station).

In addition, such locations must be supported by sufficient public service infrastructure, including sixth form provision and primary healthcare facilities.
